Happy April! We've been keeping busy...

- Please vote <u>here</u> for the member-at-large position by 4/30/23 (note: Board Members, you've already voted via separate ballot so no need to vote again).
- Mark your calendar for the annual summer chapter meeting at Grove Park from August 10-13, 2023...registration link coming soon.
- We completed our application for outstanding chapter awards.
- PHE ends May 11! VERY IMPORTANT...If you haven't seen the <u>SCDHHS bulletin</u>, please, check it out, and be sure to post this flyer all over! Per Dr. Wessinger, consider "printing the flyer in mass quantities to give to each Medicaid patient at check-in or checkout (or ask each parent with a cell phone to scan the QR Code on the flyer) as contact numbers and addresses for families have not been updated since the pandemic started. If DHHS or the MCO cannot contact patients to recertify, a significant number of those not reached will end up being temporarily disenrolled. Also, front desk staff have probably gotten out of the habit of verifying eligibility on each visit, as no one has been disenrolled since the PHE started. I would also recommend trying to make sure office staff are verifying their own contact information so that if there are denials, the office can then reach out to the families to get them to contact DHHS to re-enroll ASAP. The process will last 12 months, and most plans are looking at those who would have aged out of Medicaid already were it not for the PHE already, so pay particular attention to verifying anyone over 19. Lastly, if a patient is found to be no longer eligible, they are supposed to be given info re ACA Exchange Plans. It would be a good idea to recommend that providers



- Our nominations for the State Child Fatality Advisory Committee were accepted
  by the governor's office, and Dr. Mary Fran Crosswell was named to the committee.
  State law (SC 63-11-1930 (A) (15)) requires one position to be filled by a child abuse
  pediatrician nominated by SCAAP.
- We signed on to this year's Gun Violence Prevention (GVP) Research Roundtable FY 2024 appropriations <u>letter</u>.
- We joined this <u>sign-on letter</u> requesting \$13 million for the **Pediatric Mental Health** Care Access (PMHCA) program in FY24.
- Dr. Jill Aiken, along with Lutine and the executive committee, are embarking upon a membership effort focused on recruitment and retention!
- Dr. Edwards attended Pediatric Advisory Committee and would like to share a few items here: We are down from 97% to 95% of school students vaccinated, as rates of religious exemption are rising. Vaccine rates are lowest in Spartanburg area. WIC reports breastfeeding rates are up now to 28% from 22% among WIC families, felt to be partly related to the formula shortage. NBS for Krabbe will begin in late May 2023, and if positive, will need to be referred to a BMT specialist same day of notification.
- SCAAP meets monthly with QTIP & SCDHHS, and Dr. Beth Morphis has joined the group!
- Regarding struggles with prior auths for ADHD meds in the context of the med shortages, the amazing Dr. Wessinger shared from his colleagues at SC DHHS:
   "Below are the direct clinical PA contacts for each of the five MCOs and Healthy Connections (FFS Medicaid). Each MCO and FFS has instructed their PA team to allow any ADHD PA request for an override to extend until June 30, 2023, when being requested as an alternative for an ADHD drug that is currently unavailable due

give the beneficiaries and providers enough time to get through the shortage. The demand for ADHD medications should decrease at this time since many of the beneficiaries will be on a drug holiday during summer vacation." AAP members should feel free to raise these issues with the AAP SOAPM hassle factor form so that the AAP can advocate as well.

- Our partners at the Institute for Child Success have put together a <u>report</u> on the state of **child mental health**, and we have formed a task force of SCAAP members (Drs. Jan Key, Deandra Clark, Beth Morphis, Dane Pierce, along with our executive committee)...the group has been meeting to work on actionable ideas for each of 4 primary drivers (awareness/education, policy/advocacy, capacity building, prevention/self-care)...look forward to good stuff from this crew!
- Dr. Mack represented the chapter in a League of Women Voters panel on the AAP's position on gender-affirming care.
- Board members are in the process of completing an annual conflict of interest documentation and have voted on the career achievement award and the child advocate award...come to the SCAAP annual meeting to find out the winners!

#### **Legislative Advocacy Updates**

- Our SCAAP state house day was 3/9/23, and we focused our efforts on 988 funding, tobacco preemption, and school lunch funding. TY to our partners at ICS & Pecan Consulting! Check out the pics <a href="here!">here!</a>
- Check out the <u>legislative update</u> as of 4/1/23 shared by the incredible Maggie Cash.
- Drs. Greenhouse & Mack testified as invited experts in Senate Medical Affairs
  subcommittee in opposition to <u>S.627</u>, which proposes a **gender-affirming care** ban
  for children under 18yo and forces schools to out children before they are ready.
  Additional members testified in opposition the following week during the public

leaders <u>here</u>, Greenville online <u>coverage</u>, P&C <u>coverage</u>, Reckon <u>coverage</u>, Miles City Star <u>coverage</u>, WLTX <u>coverage</u>, ABC Columbia <u>coverage</u>, <u>ABC News4</u>, <u>WSPA</u>, <u>WRDW</u>, <u>Local Today</u>. We also received an influx of communications from grateful children and parents in response to our testimony. Here is an excerpt from one: "I am ever so passionate and pleased with the care I've been receiving. I see a future for myself now...I want to be a voice for those who don't have one, possibly alongside you."

- We continue to support the hate crime penalty enhancement <u>bill H.3014</u>, which is moving along!
- Dr. Ramkumar joined a group of stakeholders and members of the K-12 subcommittee at the state house to attempt to come to an agreement on <u>H.3309</u> (seizure safe schools) about the role of pediatricians and pediatric subspecialists in managing **children with epilepsy in schools**. TBD!
- We continue to oppose <u>S.109</u> & <u>H.3594</u> "constitutional carry." H.3594 includes a provision that would allow a CWP holder that is 18 or older to have a firearm in a "secure" glovebox, etc. of a car on a school campus- but if that bill receives review in the Senate, we will have several opportunities to advocate against that provision.
- We support <u>H.4122</u>, which would improve access to lifesaving meds, including epinephrine autoinjectors, naloxone, etc in school.
- We continue to oppose <u>S.505</u> & <u>H.3988</u>, which would allow pharmacists and pharmacy techs to test and provide treatment for certain diagnoses and would lower the age for pharmacists to provide routine vaccinations to 12 from 18yo. Dr. Mack testified on 3/8/23 against H.3988 in House 3M subcommittee, citing the specific need to preserve the medical home, especially in the context of the mental health crisis in which every visit is a mental wellness check. From the AAP: "These actions, while influenced by the policy dynamics of the current stage of the COVID-19 response and vaccination campaign, precede the pandemic. Attempts to continuously lower the ages at which children can receive pharmacy-based immunizations, or the type of immunizations received there, were being considered in state legislative sessions prior to the beginning of the current public health emergency, prompting a lengthy cycle of renegotiation over those terms. The AAP opposed the PREP Act amendments permitting pharmacy-based childhood immunizations at ages 3-18 due to the pandemic. Ensuring that children and adolescents receive the full spectrum of care in the pediatric medical home is more important than ever."
- Led by Dr. Kent Jones in partnership with geneticists and other advocates, the chapter supported <u>S.394</u> focused on providing more timely care when abnormal results appear on newborn screens...Dr. Skinner testified, and the bill passed the

the week of April 17th. Stay tuned.

 Drs. Oddo, Miller, Greenhouse, McCafferty, and Mack attended the AAP Advocacy Conference in Washington, DC, March 26-28. Members of the delegation met with the offices of Sens. Scott & Graham and Rep. Mace to discuss making the digital space safer for children.



- H.4154 designates April 4, 2023, as Children's Advocacy Center Day!
- SC Coalition for Safer Schools updates: <u>H.3360</u> passed, which would create the statewide school safety center. This bill has a good chance of getting signed into law this year if the Senate Judiciary Committee schedules it for review. The budget passed by the House includes a \$20 million line-item specifically dedicated to safety-related facility upgrades in schools meaning it provides money for things like locking classroom doors, securing school entry points, etc. Also, see this statement here following the Nashville school shooting:

The AAP Section on Critical Care (SOCC) is pleased to announce the call for applications for up to three (3) small project awards for 2023 devoted to:

- Education in Pediatric Critical Care Medicine
- Advocacy in Pediatric Critical Care Medicine
- Outcomes of Quality and Safety Initiatives in the Pediatric Intensive Care Unit

Fellows or junior faculty (5 years or less after completion of their fellowship) are eligible for awards of up to \$5,000 for one year:

\$4,000 for the project -to be provided initially

\$1000 towards travel to the 2024 <u>AAP National Conference</u>, at which awardees are <u>required</u> to submit and present an abstract of their project during the SOCC program - to be provided upon project completion with provision of a project report and confirmation of conference attendance

Note, these awards are not grants. The projects are funded initially in the form of an honorarium with the initial \$4000 check made payable to the awardee's institution with the provision of a W9 from that institution. Travel funds a year later to present the project abstract during the SOCC program at the AAP National Conference will be provided as a \$1000 check payable directly to the awardee. The Academy continues to call for needed and urgent policy action to end gun violence and protect children, families and communities throughout the country. On the heels of the school shooting in Nashville, the AAP Tennessee Chapter issued <a href="this statement">this statement</a>. The Academy also <a href="amplified">amplified</a> on social media the more than 300 pediatrician testimonials that were shared last year with lawmakers, urging Congress to take action.

## Youth Access to Psychiatry Program (YAP-P)

DMH has a grant-funded program called Youth Access to Psychiatry Program (YAP-P). For the majority of children presenting with behavioral health issues, with rapid consultation with a DMH child psychiatrist, the care of the child can continue to be managed by the pediatrician or family practice physician. Should it appear that the child has complex and serious behavioral health problems, they may need to be referred for care to a DMH mental health center, and the program's goal is to assist with those types of referrals as well.
