SCAAP receives award for public service campaign



CHARLESTON, SC — The Carolinas Healthcare Marketing and Public Relations Society (CHPRMS) awarded a Silver Tusk to the South Carolina Chapter of the American Academy of Pediatrics (SC AAP) at its annual awards banquet in Charleston in December 2022, and the award was announced during the SCAAP meeting in Charleston on January 21. The print campaign won the top honor in the category of Health and Wellness Promotion Campaigns for non-hospital and nonprofit organizations.

The campaign was developed by LaCroix Consulting to encourage masking for children during the COVID-19 surge during fall 2021 as children were returning to school. The "Mask for Me" ads encouraged masking and Covid vaccinations for children to help prevent infection and reduce the spread of Covid. The ads also positioned pediatricians as a trusted source of information for children and their parents at a time when misinformation about masking and vaccinations was rampant in the news and social media.

Randall Savely, co-executive director and chief operating officer of the South Carolina Press Association and South Carolina Newspaper Network placed the media, and graphic artist Dan Vipperman provided the artwork for the campaign.

CHPRMS is an affiliated regional chapter of the Society for Health Care Strategy & Market Development (SHSMD), a professional membership group of the American Hospital Association. The award entries are peer-judged by members of other regional chapters of SHSMD.


